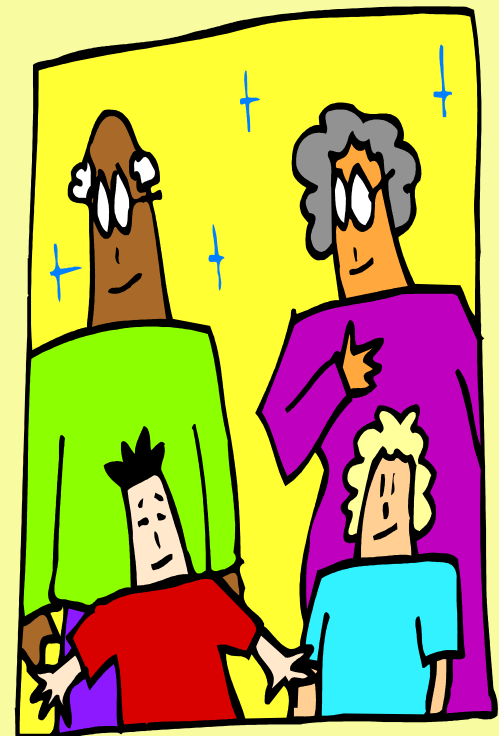

Although the focus will be on loss, interventions can be adapted for use with a variety of other populations.

- 1) Define grief, traumatic grief, and disenfranchised grief.
- 2) Articulate the continuum of parent-child relationships after separation and divorce.
- 3) Identify factors that mediate the child's experience of loss.
- 4) Implement a step-by-step model for assessing bereaved children and children of divorce.
- 5) Apply many new and innovative play therapy techniques to the treatment of bereaved children and children of divorce.
